

**RESOLUTION NO. 2016-92**

**A Resolution of the Board of County Commissioners of Boulder County approving a ballot title for the November 8, 2016 general election to extend the term limits for the Boulder County District Attorney, Twentieth Judicial District, State of Colorado.**

Recitals:

A. The Board has adopted Resolution No. 2016-91, referring a question to the November 8, 2016, general election ballot.

B. The Board desires to determine the ballot title for the question referred for placement on the ballot for the November 8, 2016, general election.

C. Pursuant to Sections 30-11-103.5 and 31-11-111(3), C.R.S., as amended, the Board must fix a ballot title according to the following guidelines: consider the public confusion that might be caused by a misleading title; avoid a title for which the general understanding of the effect of a "yes" or "no" vote would be unclear; no conflict with titles selected for any other measure that will appear on the County ballot in the same election; and the title shall correctly and fairly express the true intent and meaning of the measure.

D. The Board finds that the ballot title set forth below meets the statutory guidelines.

Therefore, the Board resolves:

1. In accordance with the statutory guidelines, the Board fixes the following ballot title for the referred question:

**COUNTY QUESTION (District Attorney Term Limit Extension to Four Terms):**

SHALL THE TERM LIMITS IMPOSED BY STATE LAW AND IN ARTICLE XVIII, SECTION 11, OF THE COLORADO CONSTITUTION ON THE OFFICE OF DISTRICT ATTORNEY OF BOULDER COUNTY, TWENTIETH JUDICIAL DISTRICT, BE MODIFIED SO AS TO PERMIT AN ELECTED OFFICEHOLDER IN THAT OFFICE TO SEEK AND, IF THE VOTERS OF BOULDER COUNTY CHOOSE TO RE-ELECT THAT PERSON TO A FOURTH TERM IN OFFICE, TO SERVE A FOURTH CONSECUTIVE TERM?

2. The Board shall take further action to finally certify the ballot measure and ballot title, together with any others that may be approved, to the November 8, 2016 general election ballot on or before September 9, 2016.

A motion to approve this Resolution 2016-92 was made by Commissioner Gardner, seconded by Commissioner Domenico, and passed by a 3-0 vote.
