Welcome to the Boulder County Clerk & Recorder online services. You can use the site to search Land, Marriage, Civil Union and Uniform Commercial Code (UCC) records or to begin the application process to obtain a marriage or civil union license.

Searching in CountyFusion

To obtain complete search results when searching by an individual's name, type the last name with an asterisk (*) before typing the first name. Do not space before or after the asterisk.
For example: Doe*John.

eMarriage - online marriage application

Prior to visiting the Boulder County Clerk & Recorders office applicants can now begin the online marriage application process by submitting their information to the county.

eCivil Union - online civil union application

Prior to visiting the Boulder County Clerk & Records office applicants can now begin the online civil union application process by submitting their information to the county.

eRecording with Boulder County

Instructions for Submitting Civil Union Application Information

This site allows you to submit information for a civil union application to the Boulder County Clerk and Recorder's Office. Your application is NOT complete until you appear in the Clerk and Recorder's Office with required documents and fee.

When you are ready to complete the application information and submit to the county, click on **Continue** at the top of this screen. You can then begin entering your information. **You must complete the information and submit to county at same time.** The application **cannot be saved** and returned to at a later time. Any items in **RED** are required information.

Once you have entered all of the requested information, please carefully review the information to ensure all is correct. There will be a green checkmark on the right hand side once all information has been completed.






